Approving Your Estimate:

Customer Acknowledges that this is an estimate and upon either verbal or written approval, this is considered a contract and the customer agrees to the terms and conditions provided within the contract estimate. The customer understands that if the work estimated and sold changes, then the price and discounts are also subject to change.

Underground Utilities:

Diamond Tree Experts does not guarantee and is not liable for any underground utilities including; Gas Lines, Power Lines, Telephone Lines, Water Lines, Sprinklers, Yard Lighting, etc. Diamond Tree Experts will 'Bluestake' all jobs that require stump grinding and we take extra precautions when using equipment for working underground.

Stump Grinding:

As stated above, Diamond Tree Experts is not responsible for any utilities underground. We will 'Bluestake' all areas where stump grinding will take place. Stump Grinding includes grinding the main stump as best as possible and any large visible surface roots with the equipment chosen for your specific job but does not include anything more unless otherwise specified on the proposal by the original arborist/estimator at the time of the estimate.

Application of Herbicide & Pesticides:

Herbicides and pesticides are used to prevent re-growth of trees and plants that are being removed or to deter and kill unwanted pests that are harming your trees and plants. This process can take multiple applications; however our initial price only includes the cost of the first application. Additional applications will have additional fees. While we do take precautions for other plant life in the area, we do not guarantee or take any liability that using herbicide will not harm other plants in the area. At the time of application, keep all children and pets away from the applied areas of the yard.

Application of Fertilizers:

Professional grade fertilizers are used for your trees, plants and grass. All fertilizers are applied using ratios depending on the size of the trees, plants, areas of the grass and the season in which the fertilizers are being applied. We recommend that our fertilizers are applied annually or bi-annually depending on the species of the trees and plants. For additional information regarding your trees and plant's needs, be sure to ask one of our Certified Arborists. For diseased or struggling trees and plants, multiple applications may be required to fully treat the situations of each tree or plant.

Accepted Forms of Payment and Payment Terms:

The following forms of payment are accepted; Cash, Certified Checks, Personal Checks and All Major Credit Cards (VISA, Master Card, Discover, and American Express). All payments are due upon completion of work unless other prior arrangements have been made with our office. A 1.5% compound interest (18% annual compound interest) will be added to all unpaid balances.



Canceled and/or Returned Checks:

There will be a \$25 additional charge to the customer for canceled and/or returned checks. In addition, the customer will be responsible for any necessary collection costs.

Discounts, Seasonal Promotions and Coupons:

All applied discounts are subject to change if the work load on an estimate being approved is changed. All seasonal promotions will be accepted if the work is approved during the promotion period. Coupons must be presented and redeemed at the time of the original estimate by the arborist/estimator and coupons must be used by the date of expiration. Only one coupon, discount or promotion can be applied to an estimate, per customer at a time.

Cancellation of Work Notice:

Diamond Tree Experts requires a 72 hour notice by the customer to cancel any approved work. There will be a \$75 cancellation fee applied to any customers that do not provide this notice. All customers that provide this notice can request our office to email a verification of cancellation to avoid any cancellation charges.
